

New Annuity Rates Effective July 22, 2024

Americo has made some rate adjustments to our Platinum Assure Series Annuity product. New contracts issued on or after July 22, 2024, will receive the new rate.

To lock in current rates, applications must be received in the Home Office by July 19, 2024, 5:00 P.M., Central. All funds on applications received by end of day on July 19, 2024, must be received in the Home Office no later than September 3, 2024, 5:00 P.M., Central, to receive the current rates.
